To this end, District personnel met with various Indian groups and representatives in Clark County, Nevada, to develop a project consistent with objectives as determined by the Indian Education Act, Part A, Title IV, Public Law 92-318. The Clark County School District has within its confines two Indian reservations, as well as a considerable number of Indian children scattered throughout the District.



Goals

 To ascertain the effect of social promotions of Indian students relative to their educational development. Parents of Indian children, students, teachers, counselors, and administrators will cooperatively review the problem and make recommendations.

2. To develop specific individualized educational programs that can be used in all schools for all Indian children consisting of accurate diagnosis and prescription.

3. To develop a group of parents, teachers, administrators, and students to investigate the causes of shyness and withdrawal of certain Indian children, and to develop some programs to alleviate those problems.

4. To develop programs that will assist the school staff in a better understanding of the culture, background, and home life of Indian children, so that a better understanding of the needs of Indian boys and girls may be reasonably attained. 5. To develop and implement programs to teach lead dian children and non-Indian children reasons why people are different.

6. To inservice e and provide junior and senior highers school counselors with the materices is and information necessary to counsel and guide Indian children replative to their needs pertaining to graduation, employment, scholarshiper availabilities, and other problem ems.
