Welcome back to the 2020-2021 school year. First, Indian Education Opportunities Program (IEOP) wants to express our hope that this newsletter finds you and your family in good health. In the light of all the recent changes to our school district with regard to COVID-19, we would like to reassure you that IEOP will do all it can to keep your family safe and informed during this school year.

IEOP welcomes and values your positive energy and dedication to excellence in all the planning it takes to have successful IEOP activities and events. The IEOP staff looks forward to partnering with parents and all CCSD American Indian/Alaska Native children this school year.

There have been some changes to the IEOP staff. Ms. Della Frank is the new coordinator II for IEOP. Ms. Mae Raiford is our returning student success Advocates (SSA). Ms. Katya Riley is the new SSA, and Ms. Regina Britt as the IEOP office specialist. The IEOP staff is dedicated to the Native community as is the Clark County Indian Education Committee (CCIEC). Together we work closely to plan meaningful cultural and academic events for all our Native students.

Student Eligibility

IEOP has a goal to increase the enrollment in the Title VI and the Johnson O'Malley (JOM) programs. We invite our enrolled members to help us get the word out to American Indian/Alaska Native families who would benefit from the IEOP services. Currently, 661 students are enrolled in Title VI program, and 435 of those students are enrolled in the JOM program.

- Title VI Formula Indian Grant
 - Descendant of a parent/grandparent with a Certificate of Indian Blood (CIB) card or letter from a federal or state recognized tribe. The following documents for Title VI eligibility are:
 - Title VI 506 Form
 - Eligible proof of descendancy for parents or grandparents or student.
 - Certificate of Indian Blood
 - Letter from Tribal Enrollment office
- Johnson O'Malley (JOM)
 - Student is an enrolled member with a Certificate of Indian Blood (CIB) card or letter of a federal or state recognized tribe. JOM students qualify for both Title VI and JOM.
 - The following documents for the JOM program are:
 - Title VI Form
 - Johnson O' Malley Form
 - Eligible proof are:
 - Tribal Certificate of Indian Blood OR
 - Tribal Letter(s) of blood quantum showing ¼ percent.

Thank you for your commitment to ensure that IEOP remains successful. It continues to be an honor and privilege to serve as the coordinator for IEOP. Together, we know we will make this school year one of growth and achievement for all AI/AN children.

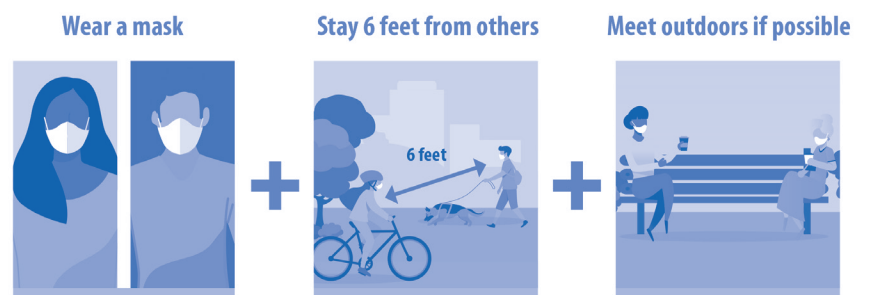

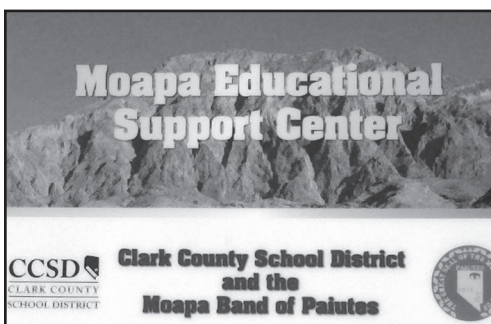

Superintendent Dr. Jesus F. Jara and Deputy Superintendent, Dr. Brenda Larsen-Mitchell visited the Moapa Educational Support Center (MESOC) located on the Moapa River Indian Reservation, Moapa, Nevada. The MESOC is supported by the Clark County School District (CCSD) Indian Education Opportunities Program (IEOP) and managed by the IEOP coordinator, Della Frank. The MESOC

opened in 2005 to meet the unique needs of the Moapa Band of Paiutes students and their families by providing academic support through K-12 tutoring, enrichment activities in core subject areas, credit retrieval assistance, Native American cultural activities, computer access, adult education and a summer science, technology, engineering, and math (STEM) program. The students on the Reservation have a safe environment with positive adult role models during the afterschool hours where they learn sportsmanship and fair play through participation

in recreational activities, how to engage in a healthy lifestyle through prevention activities, how to become actively involved in the community as well as leadership training for youth. The students who attend the MESOC see their academic success and achievement increase, their school day behavior and attendance improve, and schools become more accessible to the community. The center depends on community partnerships and collaboration to support the MESOC goals, which are to support the Clark County School District goals.

Native American Heritage Shines through Valley High School Students

Native American Heritage Month was in November of 2020, and senior Koby White and sophomore Taela Elliott show their pride in their Native American heritage, sharing their culture with others.

Both White and Elliott, who are cousins, perform traditional healing dances; White is a grass dancer, and Elliott is a jingle dancer. Both Elliott and White have traditional Native American regalia that, as Elliott explains, "can be passed down to us, made by our families, or bought from other Natives." They perform to shed light on their culture while also participating in their traditional ceremonies.

"Native Americans have often been invisible to our society," White said. "We are often viewed only in a historical context. I am proud to bring awareness to Native American issues and to show people that we are strong and resilient people and that we are still here."

White is Western Shoshone, Taos Pueblo, and African American. He uses social media to spread awareness to Natives with his content on the platform of Tik Tok. He provides content about Native Americans and their culture while also performing traditional dances, sometimes with his twin brother.



Both athletes, Elliott plays basketball and volleyball while White runs cross-country and track. Elliott plays 'rezball,' which is a highly popular basketball program among reservations.

"I think that Koby is doing a great thing by bringing attention to not only Natives as a whole but also to the things that we face today as Indigenous people," Elliott said. "It's hard to put yourself out there, especially when there are people that don't even know Natives still exist today, and he has done a good job at showing that we still exist, educating people about us."

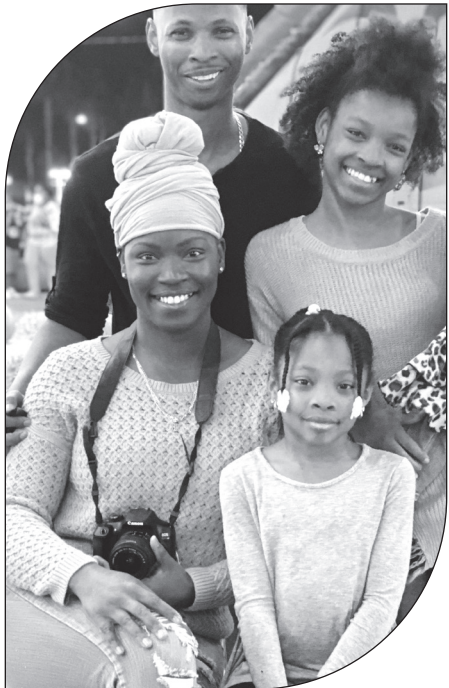
Elliott, who is Western Shoshone, explains that she was born into the traditions and history, which, she says, "are a daily part of our lives and we learn from our elders and families." She takes part in powwows, rezball (highly competitive basketball games played around all reservations), and the Nevada Native Caucus Youth Council. There are also traditional activities still practiced today.

"Examples of these," Elliott said, "would be smudging, harvesting pine nuts, hunting, using plants for medicine, sweat lodges, dancing, and drum circles."

Bringing awareness to the Native American culture is important in a time where people are examining other cultures and fighting for their own rights. Assistant Principal Thomas Smith helped to feature these two students on Valley's campus on November 12.

"I'm so excited to have both [White and Elliott] at Valley in their Traditional Indigenous Regalia honoring Native American History Month," Smith said. "As we strive to make Valley a better place and the World a better place, [White and Elliott] doing this today will serve as steps toward bringing awareness and honoring not only Indigenous Americans but ALL People of Color."
